

ART. 1 — *Topic of the guidelines*

- This document is aimed at disciplining the organization of the project *Masters Of Art for Childhood*, promoted by the non-profit, non-party and non-religious Association PENSARE oltre Cultural Movement in partnership with:
Università Internazionale per la Pace Roma
Liceo musicale-coreutico G. Pasta Como
Fondazione Franco Fossati Museo del Fumetto Milano
Fondazione Daniela Dessì
Il Giornale Off
And the recognition of ANP Associazione Nazionale Presidi Lombardia e Lazio.
- The project offers a “School Rethought” whose focus is the respect of each child singularity, their own learning time together with nature time, which are not in contradiction with the culture time. A new learning paradigm giving space to each person talent and to the natural curiosity each child has. A school allowing to acquire knowledge through the different languages of Art, cultivating the precious weave of each individual since childhood.
- At the end of the educational path, participants will be given a report/research of the new pedagogic horizon.

ART. 2 — *Objectives*

Masters of Art for Childhood

- Puts into practice a service of public interest which promotes and lead the child along their natural growing process, providing cultural and artistic tools up to satisfy their creativity and curiosity by means of an educational paradigm based on the practice of Arts, following the historical model of the atelier of the Renaissance.
- Highlights that the efficient pedagogic- didactic education provided by *Tutor of Arts* is essential to reach the contemplated results.
- Wants to realize one of the fundamental educational aims: empowerment, in opposition to the spreading fashion of diagnosing diseases.

ART. 3 — *Project addressees*

- 4/5 years old children

ART. 4 — *Management*

- The initiative organised by PENSARE oltre Cultural Movement takes place at Teatro San Babila of Milano, a magic place to learn, with its unique characteristics able to stimulate and motivate children.

The premises where the service is held match the safety criteria contemplated by law.

ART. 5 — *Organization criteria*

- The project will be operative from October 9th 2018 to May 30th 2019.
- The project is taking place in the afternoon, on tuesday and thursday from 4.30 to 6.30 (look at planning and festivities), with 15 minutes of flexibility on the time of entry and exit in the Theater.
- A person in charge of information and contacts, NOT for registration, will be present at ChiAmaMilano - via Laghetto 2, Milan - on tuesday and wednesday from 3.30 to 5.30 pm, in the months of April, May, until June 14th, and from September 1st to October 10th.
- The project offers a service of public interest with an individual enrollment, which contemplates an association enrollment share and a contribution to support the project itself.
- The project will be activated with a minimum number of 50 children.
- The presence of *Tutors of Arts* trained in the task is guaranteed, with a ratio of 1/20 children, who will support the groups of children in each activity..
- In order to grant the maximum level of surveillance and the peaceful development of activities, the *Tutors of Arts* will be supported by volunteers or students having a relevant CV, relating to the alternation School Job

ART. 6 — *Staff*

- All *Tutors of Arts* will have the above said individual qualifications of health suitability contemplated by law.

ART. 7 — *Enrollment*

- Families who want to enroll their children to the project have to subscribe using the website www.maestridarteperlinfanzia.org, in the months of April, May and September and no later than October 10th 2018.
- They have at the same time to fill in the questionnaire (privacy protection) and pay the member enrollment share of 150,00 € plus the contribution to support the project “Masters of Arts for Childhood” of 350,00 €.

ART. 8 — *Family contribution - General criteria*

- The enrollment share as a Member of *PENSARE oltre* is €150,00 and the contribution to support the project “Masters of Arts for Childhood” is € 350.00.
- As it is a Membership share and a contribution to support the project “Masters of Arts for Childhood” non refund is contemplated even in case of absence, irregular attendance (for example only once a week).
- The payment of the Membership share of a guarantor parent and the contribution to the project “Masters of Arts for Childhood” will be done outright, online by credit card or paypal or bank transfer with notice of payment (bank details will be supplied on request).

- Parents interested to enroll more than one child, upon presentation of suitable declaration, will pay a single Membership share of 150,00 € and a contribution to support the project “Masters of Arts for Childhood” of 350.00 € for each single participating child.

ART. 9 — *Norms and rules*

- A copy of this Copy of this regulation, pursuant to art. 22 of the Law of 7 August 1990, n. 241, will be kept available to the public to be read at any time.

BEHAVIOUR RULES

- Children affected by viral diseases, such as pediculosis, must not come, till the problem is solved.
- Participants are asked to respect timing in order to grant the correct fruition of the service
- Children are delivered only to adult family members authorized by mandate (as written in the questionnaire)
- It is forbidden to introduce food and beverage inside the Theatre. Children can be given only a small bottle of water during the lessons.
- Parents are asked not to give children any toy of personal objects. The organization is not responsible in case of breaking or loss.
- It is recommended not to give children any telephone during the course.
- *Tutors of Arts* and project Directors will be available for meetings with participants’ parents in case of necessity.

The undersigned gives his/her APPROVAL as of . 13 of D.Lgs. 196/2003, to the treatment of his/her personal data (and to his/her children’s data), including sensible data as of art. 4,c.11.d of D.Lgs. 196/2003, for the purposes contemplated by PENSARE oltre Cultural Movement for the realization and management of the project “Master of Arts for Childhood”.

The undersigned gives his/her APPROVAL to group or single child pictures and videos which will be used within the activities of PENSARE oltre or published in the website or social network or public projections with a duration inferior to the 3 minutes contemplated by law.
